


NORTH DAKOTA HAS FIVE TRIBES INCLUDING THE TRENTON INDIAN SERVICE AREA

Standing Rock Nation

- Agency established in 1873
- Reservation in 1889
- Total Tribal acreage: 850,000 acres

Turtle Mountain Band of Chippewa

- Agency established in 1910
- Reservation in 1975
- Total Tribal acreage: 46,000 acres

Trenton Indian Service Area

- Established in 1975
- Total Tribal acreage: 3,968,000 acres

Spirit Lake Nation

- Agency established in 1867
- Reservation in 1867
- Total Tribal acreage: 245,000 acres

Mandan, Hidatsa and Arikara (MHA) Nation

- Agency established in 1864
- Reservation in 1870
- Total Tribal acreage: 980,000 acres

Sisseton Wahpeton - Oyate Nation


- Agency established in 1867
- Reservation in 1867
- Total Tribal acreage: 108,589 acres

Spirit Lake Tribe

- Enrolled members: 7,559
- Population on reservation: 4,323 (enrolled 2,069) Counties: Benson, Nelson, Eddy and Ramsey

Sisseton Wahpeton-Oyate Tribe

- Enrolled members: 13,872
- Population on reservation: 4,393
- Counties: Marshall, Day, Codington, Grant and Roberts

Standing Rock Sioux Tribe • Enrolled members: 16,081

- Population on reservation: 8,553 (4,380 live in ND)
- Counties: Sioux, Corson, Dewey, Ziebach

DEMOGRAPHICS

Mandan, Hidatsa, Arikara Tribe

- Enrolled members: 16,770
- Population on reservation:7,611
- Counties: Dunn, McKenzie, McLean, Mercer, Mountrail and Ward

Turtle Mountain Band of Chippewa Tribe

- Enrolled members: 32,676
- Population on reservation: 9,247
- County: Rolette, Phillips, Blaine, Sheridan, Roosevelt

Trenton Indian Service Area

- Enrolled members: 1,800 Indian Health Services User Population
- Population on reservation: 2,600
- Counties: ND: Williams, Divide, and McKenzie; MT: Richland, Roosevelt, and Sheridan

Off reservation

• Roughly 50% of the Tribal population live outside reservation borders

TRIBAL HEALTHCARE FACILITIES

"WHAT DOES 638 MEAN?"

Title I

- Indian Self Determination and Education Assistance Act (ISDEAA) aka *P.L. 93-638
- Federally Recognized Tribes that *contract* or *contracts* with Indian Health Services (IHS) to plan, conduct and administer one or more individual programs functions and services, that would have been otherwise provided by IHS because of their status as Indians.
- Tribes and Tribal Organizations have the option to either (1) administer programs and services
 the IHS would otherwise provide (referred to as Title I Self-Determination Contracting) or (2)
 assume control over health care programs and services that the IHS would otherwise provide
 (referred to as Title V Self-Governance Compacting or the TSGP).

TRIBAL HEALTHCARE FACILITIES "WHAT DOES 638 MEAN?"

Title V

- Federally Recognized Tribes compact with the IHS to assume full funding control
 over programs, services, functions and activities that the IHS would otherwise provide
 for Indians because of their status as Indians.
- Similar to Title I 638 program regarding services and programs, with the major difference being oversight. Tribes can reallocate or redirect funding without IHS approval. In contrast, IHS must approve any substantial changes to a Title I contract.

INDIAN HEALTH SERVICE (IHS) "WHAT DOES IT MEAN TO BE AN IHS CLINIC?"

IHS

- A health care facility is considered an IHS clinic when all programs in the Tribal healthcare facility are administered by the U.S. Federal Government.
- IHS is an agency located in the Department of Health and Human Services
- · Headquarters in Rockville, MD
