





### Person Centered

"Person-Centered Care describes the effort to ensure that mental health a care is centered on the needs and desires of the consumer. It means that consumers set their own recovery goals and have choices in the services they receive, and they can select their own recovery support team. For mental health providers person-centered care means assisting consumers in achieving goals that are personally meaningful."

### Person Centered Guiding Principles

- •Transparency, individualization, recognition, respect, dignity, and choice related to one's person, circumstances, and relationships.
- •Support the decision making abilities and preferences of all individuals for treatment and recovery.
- •Involve persons served in the design, administration, and delivery of treatment and recovery services.
- •Respond to every individual in the context of the strengths, hopes, culture, and spirituality.
- •Interventions tailored to unique preferences, strengths, vulnerabilities, and dignity of each person.

- Tasks
- Participation and roles

#### The relationship with the provider is experienced as

- Collaborative
- Respectful

- Understanding
- Encouraging

### Moving Beyond Traditional Approaches

Traditional Approaches	Person-Directed
Disabilities and deficits drive treatment	Abilities/choices define supports
Low expectations	High expectations
Clinical stability or managing illness	Quality of life and promotion of recovery
Facility-based settings and professional supporters	Integrated settings and natural supporters are also valued
Avoidance of risk; protection of person and community	Responsible risk-taking and growth
Medicate for symptom reduction	Medicate for maximum functioning
Illness/symptom focus	Wellness/health focus

### Moving Beyond Traditional Approaches

Traditional Approaches	Person-Directed	
Professional services only	Diverse services (professional services AND self-management, peer support, holistic medicine)	
Compliance is valued	Active participation and empowerment is vital	
Linear progress and movement through an established continuum of services	Person's chooses from a flexible array of supports and/or creates new support options with team	
Only professionals have access to information (e.g., plans, assessments, records, etc.)	All parties have full access to the same information – often referred to as "transparency."	
Self-determination and community inclusion must be earned through treatment compliance and clinical stability	Self-determination and community inclusion are fundamental human rights of all people


### Treatment does not need to be voluntary to be effective.

Sanctions or enticements from family, employment settings, and/or the criminal justice system can significantly increase treatment entry, retention rates, and the ultimate success of drug treatment interventions.


